Kids DJ Entertainment reserves the right to terminate its performance if any potential harmful/destructive incident (e.g. rain, disorderly guest, etc.) is not dealt with by the client.

Kids DJ Entertainment reserves the right to work with you, and re-schedule your event at another convenient time if an unforeseen event occurs, like bad weather, accidents, or illness.
